FOUNDERS DAY

The fifteenth annual celebration in honor of William W. Cook, founder of the Lawyers Club of the University of Michigan and donor of all buildings on the Law Quadrangle, will be held on Friday, April 19, 1940. Frederick H. Wood, Esq., of the New York bar, will be the guest of honor and will deliver the principal address at a dinner which will be held at the Lawyers Club at 6:30 o'clock.

At 2:00 o'clock in the afternoon the annual second-year student inter-case-club contest will be held. At the conclusion of the competition the Henry M. Campell Award will be conferred upon the winners. A group of four second-year students who have shown the greatest

proficiency in the regular case club work during the current year will argue a moot case before a bench of distinguished judges who have been invited to hear the case. The contest, which will be held in Hutchins Hall, is open to the public.
