The more things change, the more they stay the same.


Since the 1920s, when William Wilson Cook made his legendary gifts to fund the construction of the Law Quadrangle and establish an endowment for faculty research, our student body has nearly tripled in size. The Michigan Law campus is now entirely wireless — a remarkable change that has occurred only in the past five years. Though Michigan has always been a large, national law school — as well as a pioneer in international legal education — we continue to expand our reach. Numbered among the top law schools in the world, we currently welcome students from all corners of the globe and enjoy a vibrant network of alumni spread across 50 states and throughout 73 foreign nations. As state support has dwindled, tuition rates have risen to 240 times their 1933 level (when it cost only \$138 per year to attend!). And in May 2004, we publicly launched the most significant fund raising effort in the Law School's history — a \$135 million capital campaign to finance facilities renovations, increase student and faculty support, and raise the level of annual giving.

Yet every September, our incoming students experience the magnificence of the Law Quadrangle for the first time, feeling the same awe and wonderment that we felt when we were new to the Quad. Each May, a fresh crop of Law School graduates leaves the cloister of the Quadrangle, venturing into the wide world with the knowledge and tools to make a lasting impact. Fall brings Law School reunions, when alumni return to Ann Arbor to reconnect with classmates, relive Law School memories, and root for the Maize and Blue. And season after season, year after year, members of the Law School community continue to amaze us with extraordinary gifts of time, talent, and treasure.

Thank you, alumni and friends, for the ever-changing ways you demonstrate your loyalty and generosity, and for the fundamental ways in which your constancy sustains us.


