Professor Henry Moore Bates, Dean Emeritus of the University of Michigan Law School, died on Friday, April 15, 1949, at the home of friends in Berkeley, California. He had celebrated his eightieth birthday on March 30. Death was attributed to heart failure after an attack of influenza and pneumonia. Professor Bates joined the faculty of the school in 1903 and was Dean from 1910 until his retirement in 1939.
