Grover Cleveland Grismore, Professor of Law, University of Michigan Law School, died on March 10, 1951, at his home in Ann Arbor at the age of sixty-two. A graduate of the Law School in the class of 1914, Mr. Grismore was invited immediately after his graduation to join the Faculty of the School, an association which continued for thirty-seven years. In addition to his teaching he served as Secretary of the School from 1921 to 1926 and from 1942 to 1945, and also as Secretary-Treasurer of the Lawyers Club from its opening in 1924. For many years he was a member of the Faculty Advisory Board of the *Michigan Law Review*.
